Above all, elder mediation **protects the quality of life and personal integrity of the elderly**. It **engages specialized skills** for multi-party resolution, appreciating family dynamics, determining capacity to mediate, recognizing potential for abuse, and identifying the risk for loss of benefits based on the outcome. This training will address all of these topics and more!

However, if you are interested in offering elder mediation services, it is recommended that you have either previously taken a basic mediation skills training or register for one within 6 months of taking this Advanced Mediation Training.

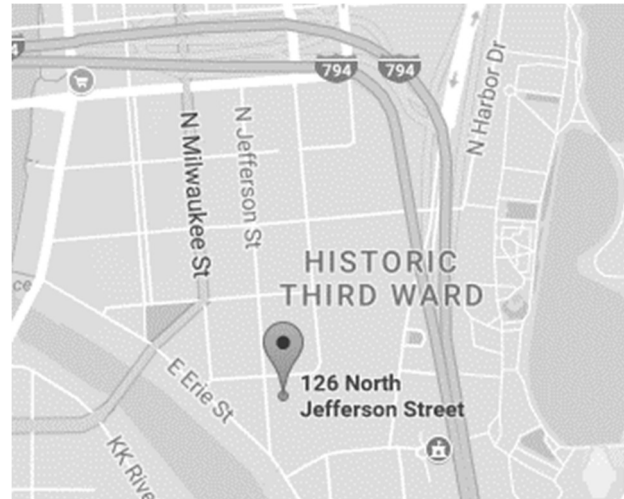
