Professional Use: This training is especially valuable to anyone (business people, attorneys, HR, social workers, and more) who deals with clients, employees, and/or family conflicts and wants more tools for handling these conflicts. The Winnebago Conflict Resolution Center is recognized by SHRM to offer Professional Development Credits (PDCs) for SHRM-CP® or SHRM-SCP®. CLE credits have been approved for attorneys (other CE credits may be available). The fee for these five sessions/forty hours of instruction is only \$825. (There is also an early-bird discount available if registered before May 7, 2021!) Also included is the opportunity to observe eight hours of WCRC mediations and to co-mediate another eight hours of actual mediations with experienced WCRC mediators.

Volunteers: Volunteer opportunities are available! The WCRC will underwrite a significant portion of your training fee if you agree to our volunteer terms and are approved by the WCRC Board of Directors as a volunteer. Volunteers must commit to serving for a minimum of five hours a month for one year for the WCRC on Thursday mornings for our small claims mediations (roughly 3-4 weeks per month). The training fee for volunteers is only \$150. (There is also an early-bird discount available if registered before May 7, 2021!)

Volunteer mediators for the WCRC have a remarkable opportunity to give back on the front lines. WCRC mediators work directly with disputants on over 450 cases annually from small claims to the largest civil actions, from family conflicts to restraining orders, and more.

Cancellation Policy: If you must cancel your registration and do so at least one week prior to the start of the training, you will only be charged an administrative fee of \$75. If you are a confirmed registrant and cancel less than one week prior to the start of the training, we cannot provide a refund of your registration. Registrations are transferrable.
